IN THE SUPREME COURT OF INDIA EXTRA-ORDINARY APPELLATE JURISDICTION SPECIAL LEAVE PETITION (CIVIL) No. 11356 OF 2019 WITH PRAYER FOR INTERIM RELIEF

SHASHANK CHANDRANANT JAIN AND ANOTHER VERSUS Respondent(s)

WHEREAS the Petition for Special Leave to Appeal with prayer for interim relief along above mentioned (copy enclosed) in the Registry by Mr. UDAYADITYA BANERJEE, Advocate on behalf of the Petitioner(s) above, was listed for hearing before this Court on 05th May, 2019 when the Court was pleased to pass the following order:

Issue notice. In the meantime, there shall be stay of further proceedings in Suit No. 3827 of 2023 pending before the Bombay High Court until further orders. AND WHEREAS, the matter above-mentioned was listed before Ld. Registrar's Court on 27th April, 2023. When the matter was listed for disposal, the following order was passed: Respondent no. 1 has filed counter affidavit. Service is complete on respondent nos. 2,3 and 5 to 7 but none has entered appearance.

Official report states that office has received counter affidavit sent by post by respondent no. 4 wherein the respondent has stated that they do not wish to file reply themselves or to engage the services of an Advocate. Ld. Counsel for the petitioner is granted four weeks time to take appropriate steps including filing application for substituted service. If application is filed within one week, same be treated as allowed and thereafter four weeks time is granted for filing proof of publication.
